	(2.1) Install properly the landing gear control bellcrank bolt M6x26 LN9037 and its washers and nut in accordance with the accomplishment instructions of DG-Flugzeugbau TN No. 800/40 and with Maintenance Manual Diagram 15 section A-A.	
	(2.2) Inspect the air brake control pushrod (Part Number (P/N) 6St13) and the wing flap control pushrod (P/N 8St7) for damage, and if any pushrod is damaged, replace it with a serviceable part in accordance with the accomplishment instructions of DG-Flugzeugbau TN No. 800/40.
